TERMS AND CONDITIONS

This contract describes the agreement and includes all contractual obligations made between **"Paws Country Club Inc."** hereinafter referred to as **"Kimberly Vazquez"** or **"I"** or **"WE"** or **"OUR"** or **"US"** and **"Client"** hereinafter referred to as **"CLIENT"** or **"YOU"** or **"YOUR"** on (Date). The Dog Boarder and The Client are each referred herein as a **"PARTY"** and collectively known as the **"PARTIES"**.

The client wishes to engage the dog boarder as a contractor to perform the services listed in this agreement. This dog boarding service contract is since it was signed, i.e. from (Date) to (Date) according to the agreement of the parties.

BOOKING AND SERVICE PRICING:

Service date for client will be guaranteed once the contract is signed. The balance will be due on the day the service starts. The client agrees and is willing to pay fees for the services we provide, which are as follows:




PAYMENT:




The client must pay a 50% (fifty percent) deposit at the time of booking if the reservation is longer than 30 (thirty) days and the remaining balance must be paid no later than 48 (forty eight) hours before boarding begins. If the client picks up the dog later than arranged then additional payment will be required. The client will pay an important additional fee for the care of the dog. This includes but is not limited to dog food, litter or cleaning supplies, transportation, unexpected visits, and emergency health care costs. The dog boarder shall retain and submit receipts as proof of additional expenses. If the fees are not paid in full, the dog boarder has the right to terminate the agreement with the client, and there will be no further obligations to the client. All payments can be made by Zelle, or Cash.

REGISTRATION AND MEDICAL CONDITIONS:






The client must complete the registration form in this contract with important information. The client must provide accurate information about any medical conditions in the client's dog and any special needs. This is necessary and greatly influences the smoothness, convenience and/or flexibility of the dog boarder in carrying out its service duties to clients.

DOG BOARDER RESPONSIBILITY:



The Dog Boarder will perform all reasonable duties as specified in this agreement in a responsible, professional and caring manner. The Dog Boarder will comply with all dog boarding industry regulations and compliance. The dog sitter will provide clients with regular updates on the dog's progress during their stay and will promptly notify the client of any incident that could affect the dog's health and well-being. The dog boarder reserves the right to board other well-suited dogs at the same time, unless an individual board has been chosen.

CLIENT RESPONSIBILITY:



The client must ensure that each dog has a collar and tag. The client should provide a properly functioning lead/harness as well as a muzzle if required. The client must provide valid and complete information in the registration form in this dog boarding service agreement because this information is really needed by the dog boarder.

LIABILITY/OBLIGATION:

The client must indemnify the dog boarder in respect of all costs incurred for damages, from any claim, to any person or animal that suffers injury or death caused by the client's dog. The dog boarder shall not be liable for any accident, of any kind, which may be caused to the dog or caused by the dog, who has unsupervised access to the outdoors.

CANCELLATION:

Either party can terminate this agreement by giving written notice of termination to the other party within 48 (forty eight) hours which can be done via email or sms or chat. If the client's dog becomes aggressive or dangerous, the dog boarder has the right to terminate this agreement and the dog boarder will immediately contact the client or emergency contact to arrange for the dog to be moved. Any false or misleading information on the hostel registration form may be considered a violation of the terms of this agreement and form grounds for immediate termination. And this termination of this agreement will not entitle the client to a refund or relief on payment of any balance due.

EMERGENCIES:

In an emergency, the dog boarder should contact the client to confirm the client's choice of action. If the client cannot be contacted in time then the dog renter is authorized to:

- Take the dog to the vet listed on the boarding registration form.
- Request on-site treatment from a veterinarian.
- Take the dog to an emergency clinic if the previous 2 (two) options are not possible.

CONFIDENTIALITY:

The dog boarder will maintain the security and confidentiality of all keys, house access codes, security and personal information of the client, and will not be made available or shared with other parties at any time in any way without written consent of the client. All client property will be returned to the client either at the end of the agreement or when requested by the client.

VIDEO AND PHOTOGRAPHY:

It is agreed that "**Paws Country Club Inc.**" reserve the right to use all photographs of the Pet for advertising and promotional purposes on our website, portfolio, social media, brochure, and other non-commercial purposes as "**Paws Country Club Inc.**" deems fit. It is the client's responsibility to notify "**Paws Country Club Inc.**" in writing about photos or videos that do not wish to be published.
